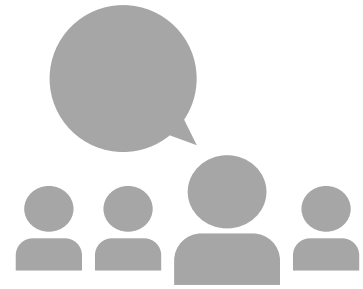


What we offer

- Participate in writing industry/position papers and sectorial reports

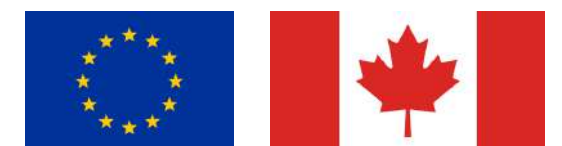

- Publication of company news on the EUCCAN website, newsletter and social media

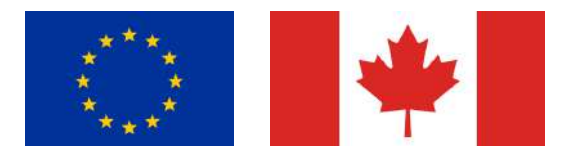
